Public Hearing - April 29, 2021

1. Approval of 2021-22 Budget

Motion to approve the following resolution:

WHEREAS, the Hillside Board of Education adopted a tentative budget on March 18, 2021 to be submitted to the Executive County Superintendent of Schools for approval; and

WHEREAS, the tentative budget was approved by the Executive County Superintendent of Schools on April 19, 2021; and

WHEREAS, the tentative budget was advertised in the legal section of the Star Ledger on April 26, 2021; and

WHEREAS, the tentative budget was presented to the public during a public hearing on April 29, 2021; and

WHEREAS, the total amount of the budget for General Fund Expenses shall be \$63,105,708 of which \$30,526,495 shall be raised by tax levy; and

WHEREAS, the total amount of the budget for Special Revenue Fund Expense shall be \$5,419,623, of which \$333,840 shall be transferred from the general fund; and

WHEREAS, the total amount of the budget for Debt Service Expense shall be \$0, of which \$0 shall be raised by tax levy.

NOW THEREFORE, BE IT RESOLVED that the Hillside Board of Education hereby adopts the 2021-22 Fiscal Year budget; and,

BE IT RESOLVED that there should be raised in taxes for the General Fund \$30,526,495 for the ensuing School Year (2021-22).


